#### ADAMAS RESIDENCIES European research residencies in law

Inspired by **artist residencies**, the Adamas residences aim to explore **contemporary law issues** by encouraging **the exchange between lawyers**, **artists and researchers**.

The Adamas residencies offer jurists from different law areas a place to carry out research in a unique **cultural and historical heritage site**, a laboratory for law and culture. For ten days or so, the residents have a space to freely work on their research. The residency is also an opportunity to **exchange with artists and professionals from other backgrounds**.

Since 2021, the Adamas programme has been run by the **Château de Goutelas, Heritage site for Culture**, in partnership with the **Constitutional Council**, the **International Nuremberg Principles Academy**, the **International Association of Economic Law** (A.I.D.E.) and the **Institute for Studies and Research on Law and Justice** (IERDJ).

## **TERMS AND CONDITIONS**

The lawyers participating in the project receive a research award from one of the partners. This 2024 edition will be held **from 6 to 15 September**.

#### Accommodation

Residents are hosted in the castle, in single rooms. Work spaces are available. The castle is equipped with fiber optics and wifi.

### Funding

Residents receive a grant of **500 euros**. Full board at the château and transportation costs are fully covered.

### Family and children

Residents may come accompanied (subject to the availabilities at the castle). The stay of additional persons will not be taken in charge.

Residents have **free time to work on the project of their choice** during their stay.

In the course of the week, there will be a **meeting with all the partners** of the programme.

At least one meeting is also planned with **artists in residence** at the Château de Goutelas; this time may take the form of a workshop.

## CHÂTEAU DE GOUTELAS Heritage site for Culture

The Château de Goutelas, located in Forez, in the heart of the Auvergne-Rhône-Alpes region, is **a place of life, creation and numerous openings:** shows, concerts, exhibitions, seminars, thematic meetings, research and creation residencies.

Goutelas, which has been awarded "Heritage site for Culture" by the French Ministry of Culture, has developed its project around three values that are part of its history: humanism, law and creation. In 1960, volunteers from all backgrounds mobilized to restore the castle, which was in danger of falling into ruins, driven by the desire to "do things together" and by the shared vision of a multicultural place. A number of lawyers took part in the work, helping to make Goutelas a place for reflection on the law, and for the agricultural world, a forum for the exchange of ideas.

Today, thanks to the originality of its history, Goutelas has become a place where **contemporary creation mingles with debates** to explore major contemporary issues: ecology and our relationship with life, human rights, new technologies, etc.

### The Constitutional Council

Every year, the Constitutional Council awards a prize to a thesis on constitutional justice and its history, or on the other competences of the Constitutional Council. The purpose of this prize is to consolidate the link between the University and the Constitutional Council, by remaining as close as possible to doctrinal research and by supporting a doctor of law, in particular by financing the publication of his or her work. On the initiative of the President of the Constitutional Council, the winner of this thesis prize is invited to participate in the ADAMAS residencies.

It is located in Nuremberg, the birthplace of modern international criminal law. Conscious of this historic heritage, its main fields of activity include providing a forum for dialogue by convening international conferences and expert meetings, conducting interdisciplinary and applied research, engaging in specialised capacity building for practitioners of international criminal law and human rights education. The Nuremberg Academy upholds the Nuremberg Principles and the rule of law with a vision of sustainable peace through justice, furthering knowledge and building capacities of those involved in the judicial process in relation to core international crimes. The Nuremberg Academy was established by the Federal Republic of Germany, the Free State of Bavaria and the City of Nuremberg.

#### Institute for Studies and Research on Law and Justice (IERDJ)

The Institute for Studies and Research on Law and Justice was born from the merger of two entities with decades of experience: the Institut des Hautes Études sur la Justice on the one hand and the Mission de Recherche Droit et Justice on the other, whose missions it carries out and continues. The aim of the grouping is to promote original and prospective thinking, to develop and support research, and to mobilize and disseminate knowledge on standards, legal regulation, and the missions and functioning of justice, in all relevant disciplinary fields. Its action is aimed at all the professionals concerned, at research and training actors, as well as at a wider public, at the national, European and international levels.

The IERDJ awards two research prizes each year, the Jean Carbonnier Prize for research on law and justice and the Vendôme Prize, awarded jointly with the Ministry of Justice. These two prizes are awarded for first-rate research in law and social sciences (Jean Carbonnier Prize) or in the criminal field (Vendôme Prize). They demonstrate the IERDJ's support for young researchers working in the fields of law and justice.

It brings together lawyers and economists, managers and political scientists, theoreticians and practitioners who consider it essential to engage in interdisciplinary reflection. In order to promote exchanges and collaboration between researchers, teachers and practitioners, the A.I.D.E. organises colloquia and seminars. It runs transnational networks for research and practical reflection.

In addition, it publishes the Revue Internationale de Droit Économique, R.I.D.E. and disseminates information on the activities of its members and on the main international initiatives taken in the field of economic law. The A.I.D.E. is supported by the Wallonia-Brussels Federation.

Since 2021, the A.I.D.E. awards a prize intended to co-finance the research stay of a young researcher in the framework of the Adamas residencies.
