Welcome Address

On behalf of the International Nuremberg Principles Academy (Nuremberg Academy) and the Office of the High Representative for Bosnia and Herzegovina (OHR), we welcome you to the conference “Criminalising Genocide Denial: Law, Accountability and Prevention”.

The Nuremberg Academy was established by the Federal Republic of Germany, the Free State of Bavaria and the City of Nuremberg. Located at the historic Nuremberg Palace of Justice and dedicated to supporting the worldwide application of international criminal law, the Nuremberg Academy advances the Nuremberg Principles with a vision of furthering sustainable peace through justice. This is the Academy’s first event in Bosnia and Herzegovina.

Since their formulation by the United Nations International Law Commission in 1950, the Nuremberg Principles have been among the most authoritative elements forming the modern foundations of international criminal law. The influence of these Principles has also been reflected in the statute and jurisprudence of the International Criminal Tribunal for the former Yugoslavia (ICTY), which was established in 1993. The ICTY has made a significant contribution to ensuring accountability for international crimes, with the stated aim of advancing the restoration and maintenance of peace in the region. The trials held in The Hague, combined with the ongoing local war crimes proceedings, helped establish historic and legal facts about the crimes committed in Bosnia and Herzegovina and throughout the former Yugoslavia. They identified those responsible for their planning and execution. The ICTY determined that the crimes committed in Srebrenica constituted genocide. This was the first time that an international court had held perpetrators accountable for this crime on European soil since it was defined in the Genocide Convention in 1948.

Despite the overwhelming judicial evidence, outright and malevolent denial of mass atrocities and genocide persist. This injustice is accompanied by various forms of trivialisation and minimisation which downplay the historical impact and gravity of these crimes. We are currently witnessing a situation where this unfortunate reality continues unabated at both national and international levels. Rather than representing a marginal phenomenon, denial has become normalised over the past three decades. In fact, we observe a distressing surge in denial that has reached an extent that poses a threat to peace. This is a warning that has also been repeatedly and ominously sounded by various UN Special Advisors.

Denial is an affront towards the dignity of victims and survivors. Further, denialism and glorification of convicted war criminals contribute to social polarisation and prevents society from confronting the atrocities and legacies of the past. It exacerbates fault lines and comes in the way of societal healing. The fuelling of such virulent hatred increases the possibility and likelihood that such crimes will recur. It is against this backdrop that this year we observed the 30th anniversary of the Srebrenica genocide and reflect upon 30 years of peace in Bosnia and Herzegovina that was brought about by the Dayton Peace Agreement.

Uvodno obraćanje i riječi dobrodošlice

U ime Međunarodne akademije nürnberških principa (Nürnberške akademije) i Ureda visokog predstavnika za Bosnu i Hercegovinu (OHR), želimo vam dobrodošlicu na konferenciji pod nazivom "Kriminaliziranje negiranja genocida: Pravo, odgovornost i prevencija".

Nürnberška akademija osnovana je od strane Savezne Republike Njemačke, Slobodne Države Bavarske i Grada Nürnberga. Smještena u historijskoj Nürnberškoj palati pravde, posvećena pružanju podrške u primjeni međunarodnog krivičnog prava u cijelom svijetu, Nürnberška akademija promovira Nürnberške principe s vizijom unapređenja održivog mira putem pravde. Ovo je prva manifestacija u organizaciji Nürnberške akademije koja se održava u Bosni i Hercegovini.

Od kada ih je 1950. godine formulirala Komisija Ujedinjenih naroda za međunarodno pravo, Nürnberški principi spadaju u red najautoritativnijih elemenata koji čine moderne temelje međunarodnog krivičnog prava. Utjecaj ovih principa ogleda se i u statutu i jurisprudenciji Međunarodnog krivičnog suda za bivšu Jugoslaviju (MKSJ), osnovanog 1993. godine. MKSJ je značajno doprinio osiguravanju odgovornosti za međunarodne zločine, s deklariranim ciljem unapređenja obnove i održavanja mira u regiji. Suđenja održana u Hagu, u kombinaciji s tekućim domaćim postupcima za procesuiranje ratnih zločina, pomogla su utvrditi historijske i pravne činjenice o zločinima počinjenim u Bosni i Hercegovini i širom bivše Jugoslavije. U ovim suđenjima su identificirane osobe odgovorne za njihovo planiranje i izvršenje. MKSJ je utvrdio da zločini počinjeni u Srebrenici predstavljaju genocid. To je prvi put da je jedan međunarodni sud na evropskom tlu utvrdio odgovornost počinitelja za ovaj zločin otkako je isto krivično djelo definirano u Konvenciji o genocidu 1948. godine.

Uprkos neoborivim sudskim dokazima, otvoreno i zlonamjerno negiranje masovnih zločina i genocida i dalje traje. Ovu nepravdu prate različiti vidovi trivijalizacije i minimiziranja, koji umanjuju historijski utjecaj i percepciju ozbiljnosti ovih zločina. Trenutno svjedočimo situaciji u kojoj ovakva zlosretna stvarnost i dalje ne jenjava ni na državnom niti na međunarodnom planu. Umjesto da predstavlja samo marginalan fenomen, negiranje u posljednje tri decenije prerasta u jedno normalizirano stanje. Zapazili smo zapravo pojavu uznemirujućeg porasta negiranja koja dostiže razmjere koje predstavljaju prijetnju miru. Ovo je upozorenje koje su različiti specijalni savjetnici UN-a u više navrata izričito i s ozbiljnošću naglašavali.

Negiranje predstavlja uvredu dostojanstva žrtava i preživjelih. Pored toga, negacionizam i veličanje osuđenih ratnih zločinaca doprinose društvenoj polarizaciji i sprječavaju društvo da se suoči sa zločinima i naslijeđem prošlosti. Njime se produbljuju društvene podjele i ometa proces iscjeljenja društvene zajednice. Poticanjem ovakve zloćudne mržnje povećava se mogućnost i vjerovatnoća ponavljanja sličnih zločina. Upravo u tom kontekstu obilježavamo 30. godišnjicu genocida u Srebrenici i osvrćemo se na 30 godina mira u Bosni i Hercegovini koji je uspostavljen Dejtonskim mirovnim sporazumom.

In May 2024, the UN General Assembly decided to strengthen its efforts at genocide prevention through remembrance and education by designating 11 July as the International Day of Reflection and Commemoration of the 1995 Genocide in Srebrenica. The first worldwide observation of this Day encourages us to continue our efforts to ensure that the truth endures in relation to the genocide perpetrated in July 1995. It reaffirms our commitment to promote decisive action underlining that, for repairing relations between former conflicting communities, the disdainful behaviour of denying them must not be tolerated.

Throughout the next two days, we will address the benefits and challenges of curbing denial and the glorification of international crimes, by legal means. We will discuss existing challenges in the prosecution of instances of denial and glorification in the Bosnian Herzegovinian context. We will construct a dialogue by looking at the experiences of other communities and jurisdictions in addressing the threats that emanate from genocide denial and historical revisionism. In particular, the experiences addressing this phenomenon in the context of the Holocaust and the genocide in Rwanda and the genocide perpetrated against the Yazidi community, will complement the discussion and enhance future practice. These experiences will also offer insights into how a decisive non-tolerance line against denial, as a particularly grave form of hate speech and incitement to hostility and violence, can be reconciled with freedom of expression. We will delve into these topics both in relation to the public and online spheres.

The provisions criminalising denial and glorification introduced into the Criminal Code of Bosnia and Herzegovina in 2021 adheres to the EU Framework Decision against Racism and Xenophobia of 2008. Our deliberations aim to ensure that Bosnia and Herzegovina's future legal responses are further harmonised with established European and international standards. A lack of decisive action nurtures a culture of impunity. At the same time, there are obvious limitations to curbing denialism by law if there are no adequate efforts for remembrance and education about the past. We will deepen the exchange on the consequences of impunity by considering the reality on the ground in Bosnian-Herzegovinian communities. We will also examine civil society experiences in preserving the memory and honouring the victims of the Holocaust, the genocide against Tutsi in Rwanda, and the recent genocide against the Yazidi people. These reflections will highlight the best approaches to overcoming prevailing conditions that have allowed the emergence of violence in the past. Crucially, we hope that these efforts will foster a culture of prevention on individual and institutional levels.

We thank all the distinguished international and national panellists and participants for sharing their rich experiences and expertise for the fight against impunity. We also extend our gratitude to our partners, the German Foundation for International Legal Cooperation (IRZ) and TRIAL International, without whom the endeavour to making this conference a success would not have been possible. We look forward to two days of deliberation and thank you for joining us on this important platform.

U maju 2024. godine, Generalna skupština UN-a odlučila je pojačati svoje napore u prevenciji genocida putem očuvanja sjećanja i putem obrazovanja, proglašavajući 11. juli Međunarodnim danom sjećanja i obilježavanja genocida u Srebrenici 1995. godine. Prvo globalno obilježavanje ovog dana podstiče nas da nastavimo s naporima u osiguravanju da istina o genocidu počinjenom u julu 1995. godine ostane trajno prisutna. Time se ponovno potvrđuje naša opredijeljenost za preduzimanje odlučnih koraka, uz naglašavanje da se za obnovu odnosa između bivših sukobljenih zajednica ne smije tolerirati ovakvo prezirno ponašanje koje se ogleda u negiranju tih zločina.

Tokom naredna dva dana, raspravljat ćemo o prednostima i izazovima u suzbijanju negiranja i veličanja međunarodnih zločina pravnim sredstvima. Diskutirat ćemo o postojećim izazovima u procesuiranju slučajeva negiranja i veličanja u bosanskohercegovačkom kontekstu. Izgradit ćemo dijalog osvrćući se na iskustva drugih zajednica i jurisdikcija u suočavanju s prijetnjama koje proizlaze iz negiranja genocida i historijskog revizionizma. Konkretno, iskustva u suočavanju s ovim fenomenom u kontekstu Holokausta, genocida u Ruandi i genocida počinjenog nad etno-religijskom zajednicom Jezida, doprinijet će raspravi i unaprijediti buduću praksu. Ova iskustva će takođe pružiti uvid u to kako se jedan odlučan pristup bez tolerancije prema negiranju, kao posebno teškom obliku govora mržnje i poticanja netrpeljivosti i nasilja, može uskladiti s pravom na slobodu izražavanja. Ovim temama ćemo pristupiti kako u sferi javnog tako i u sferi internetskog prostora.

Odredbe kojima se kriminaliziraju negiranje i veličanje, uvedene u Krivični zakon Bosne i Hercegovine 2021. godine, usklađene su s Okvirnom odlukom Vijeća EU o suzbijanju određenih oblika i načina izražavanja rasizma i ksenofobije krivičnopravnim sredstvima iz 2008. godine. Naše diskusije imaju za cilj osigurati da budući pravni odgovori Bosne i Hercegovine budu dodatno usklađeni sa ustaljenim evropskim i međunarodnim standardima. Nedostatak odlučnih mjera potiče kulturu nekažnjivosti. Istovremeno, postoje jasna ograničenja u mogućnosti zakonskog obuzdavanja negacionizma ukoliko se ne ulože adekvatni naponi u pravcu očuvanja sjećanja i edukaciji o događanjima u prošlosti. Produbit ćemo razmjenu mišljenja o posljedicama nekažnjivosti tako što ćemo razmatrat i stvarnost koja postoji na terenu u bosanskohercegovačkim zajednicama. Takođe ćemo ispitati i iskustva civilnog društva u očuvanju sjećanja i odavanju počasti žrtvama Holokausta, genocida nad narodom Tutsi u Ruandi i žrtvama nedavnog genocida nad etno-religijskom zajednicom Jezida. Ovim razmišljanjima ukazat ćemo na najbolje pristupe za prevazilaženje postojećih uvjeta koji su omogućili pojavu nasilja u prošlosti. Od presudne važnosti je to što se nadamo da će ovi naponi doprinijeti uspostavljanju kulture prevencije kako na individualnom tako i na institucionalnom planu.

Zahvaljujemo se svim uglednim međunarodnim i domaćim panelistima i učesnicima na tome što će podijeliti svoja bogata iskustava i stručnost u borbi protiv nekažnjivosti. Takođe se zahvaljujemo i našim partnerima, Njemačkoj fondaciji za međunarodnu pravnu saradnju (IRZ) i organizaciji TRIAL International, bez čije podrške ostvarenje uspjeha ove konferencije ne bi bilo moguće. Located at the historic venue of the Nuremberg Trials, the International Nuremberg Principles Academy contributes to the advancement of knowledge, understanding and enforceability of international criminal law. THE OFFICE OF THE HIGH REPRESENTATIVE FOR BOSNIA AND HERZEGOVINA

The Office of the High Representative (OHR) is an ad hoc international institution responsible for overseeing the implementation of the civilian aspects of the Peace Agreement that ended the war in Bosnia and Herzegovina. The position of High Representative was created under the General Framework Agreement for Peace in Bosnia and Herzegovina, commonly known as the Dayton Peace Agreement, which was negotiated in Dayton, Ohio, and signed in Paris on 14 December 1995. The High Representative works with the people and institutions of Bosnia and Herzegovina and the international community to ensure that Bosnia and Herzegovina evolves into a peaceful and viable democracy on course for integration in Euro-Atlantic institutions.

THE GERMAN FOUNDATION FOR INTERNATIONAL LEGAL COOPERATION

(Deutsche Stiftung für Internationale Rechtliche Zusammenarbeit e.V., IRZ)

The IRZ is a non-profit organisation which supports transition states in reforming their legal systems. IRZ was established in 1992 and receives funding from the German Federal Ministry of Justice, the Federal Foreign Office and the EU. In the Western Balkans, it started its activities in 2000 as part of Germany's contribution to the Stability Pact for Southeastern Europe. IRZ provides support in legal drafting, strategy development, monitoring and reporting on processes, as well as in the training of legal practitioners, scholars and students, including in the fields of transitional justice and dealing with the past.

CHRISTIAN SCHMIDT

High Representative for Bosnia and Herzegovina

Christian Schmidt has been serving as the High Representative for Bosnia and Herzegovina since August 2021. He studied law at Friedrich-Alexander-Universität Erlangen-Nürnberg and Université de Lausanne and worked as a lawyer. From 1990 to 2021, he represented the constituency of Fürth as a directly elected member of the German Bundestag. From February 2014 to March 2018, he served as the Federal Minister of Food and Agriculture. Prior to that, he was the Parliamentary State Secretary at the Federal Ministry of Defence for eight years and briefly at the Federal Ministry for Economic Cooperation and Development. Additionally, since 2006, he has been the President of the German Atlantic Association and, since 2018, the Deputy Chairperson of the Hanns-Seidel Foundation.

PROF. DR. CHRISTOPH SAFFERLING

Director, International Nuremberg Principles Academy

Professor Christoph Safferling is the Director of the International Nuremberg Principles Academy. He is also Professor of Criminal Law, Criminal Law Procedure, International Criminal Law and Public International Law and the Director of the International Criminal Law Research Unit at Friedrich-Alexander-Universität Erlangen-Nürnberg (FAU). Previously, he was Professor of International Criminal Law at the Philipps-University Marburg, where he was also the Director of the International Research and Documentation Centre War Crimes Trials (ICWC). Professor Safferling is the Whitney R. Harris International Law Fellow of the Robert H. Jackson Center in Jamestown, New York and was a visiting scholar at the Stanford Center for Human Rights and International Justice. He was a member of the Independent Academic Commission at the Federal Ministry of Justice for the Critical Study of the National Socialist Past and has undertaken a study on the history of the Federal General Public Prosecutor. His books include *International Criminal Procedure* (Oxford 2012), *The Rosenberg File: The Federal Ministry of Justice and the Nazi Era* (co-authored with Manfred Görtemaker, C.H. Beck 2016) and *State Security in the Cold War: The Federal Prosecutor's Office between the Nazi Past, the Spiegel Affair, and the RAF* (co-authored with Friedrich Kießling, dtv 2021).

MINKA KREHO

Acting President, Court of Bosnia and Herzegovina

Minka Kreho graduated from the School of Law, University of Sarajevo, in 1987. She passed the exam for misdemeanour judges and initially serves as a legal advisor at the Municipal Misdemeanour Court of Sarajevo's Centar Municipality. In 1991, she was appointed as a misdemeanour judge at the same court. In 1993, she passed the bar exam and was appointed as a judge at the Municipal Court I Sarajevo in 1995. In 2003, she was appointed judge at the Cantonal Court in Sarajevo. Since 2007, she has worked on war crimes cases as a judge at the Court of Bosnia and Herzegovina and served as the President of the Court's Education Committee. For several years, she has acted as a criminal justice trainer and educator on behalf of the OSCE Mission to BiH. She served as Acting President of the Court since December 2023.

CHRISTIAN SCHMIDT

Visoki predstavnik za Bosnu i Hercegovinu

Christian Schmidt obavlja dužnost visokog predstavnika za Bosnu i Hercegovinu od avgusta 2021. godine. Studirao je pravo na Univerzitetu Friedrich-Alexander Erlangen-Nürnberg te na Univerzitetu u Lausanni, a radio je i kao advokat. U periodu od 1990. do 2021. godine predstavljao je izbornu jedinicu Fürth kao direktno izabrani zastupnik u njemačkom Bundestagu. U periodu od februara 2014. do marta 2018. godine obavljao je dužnost saveznog ministra poljoprivrede i prehrane. Prije toga, osam godina je bio parlamentarni državni sekretar u Saveznom ministarstvu odbrane, a nakratko i u Saveznom ministarstvu za ekonomsku saradnju i razvoj. Pored toga, od 2006. godine predsjednik je Njemačkog atlantskog udruženja, a od 2018. zamjenik predsjednika Fondacije Hanns-Seidel.

PROF. DR. CHRISTOPH SAFFERLING

Direktor, Međunarodna akademija nürnbergskih principa

Profesor Christoph Safferling je direktor Međunarodne akademije nürnbergskih principa. Takođe je i profesor prava u oblastima krivičnog prava, krivičnog postupka, međunarodnog krivičnog prava i međunarodnog javnog prava na Univerzitetu Friedrich-Alexander Erlangen-Nürnberg (FAU) te direktor Istraživačke jedinice za međunarodno krivično pravo pri FAU. Prethodno je bio profesor međunarodnog krivičnog prava na Univerzitetu Philipps u Marburgu, gdje je ujedno obavljao i funkciju direktora Međunarodnog centra za istraživanje i dokumentiranje suđenja za ratne zločine (ICWC). Profesor Safferling je saradnik Instituta za međunarodno pravo Whitney R. Harris pri historijskom centru Robert H. Jackson u Jamestownu, New York, te gostujući istraživač na Stanford centru za ljudska prava i međunarodnu pravdu. Bio je član Nezavisne akademske komisije pri Saveznom ministarstvu pravde za kritičko proučavanje prošlosti nacionalsocijalističkog režima te je proveo studijsko istraživanje o historiji funkcije saveznog generalnog javnog tužioca. Njegove knjige uključuju *Međunarodni krivični postupak* (engl. *International Criminal Procedure*, Oxford 2012), *Dosje Rozenburg: Savezno ministarstvo pravde i nacistička era* (engl. *The Rosenberg File: The Federal Ministry of Justice and the Nazi Era* - u koautorstvu s Manfredom Görtemakerom, C.H. Beck 2016), *Državna sigurnost u Hladnom ratu: Ured Saveznog tužilaštva između nacističke prošlosti, afere Spiegel i ljevičarske terorističke organizacije Frakcija Crvene Armije* - (engl. *State Security in the Cold War: The Federal Prosecutor's Office between the Nazi Past, the Spiegel Affair, and the RAF*, u koautorstvu s Friedrichom Kießlingom, dtv 2021).

MINKA KREHO

V.d. predsjednice, Sud Bosne i Hercegovine

Minka Kreho je diplomirala na Pravnom fakultetu Univerziteta u Sarajevu 1987. godine. Položila je ispit za sudiju za prekršaje i radila kao pravna savjetnica u Općinskom sudu za prekršaje Općine Centar Sarajevo. Godine 1991. imenovana je na poziciju sutkinje za prekršaje na istom sudu. Godine 1993. položila je pravosudni ispit, a 1995. imenovana na poziciju sutkinje Općinskog suda I Sarajevo. Godine 2003. imenovana na poziciju sutkinje Kantonalnog suda u Sarajevu. Od 2007. godine radi na predmetima ratnih zločina kao sutkinja Suda Bosne i Hercegovine, te kao predsjednica Odbora za edukaciju ovog Suda. Nekoliko godina radi kao predavač i edukator u oblasti krivičnog pravosuđa u ime Misije OSCE-a u BiH. Od decembra 2023. godine obavlja dužnost v.d. predsjednice Suda BiH.

MILANKO KAJGANIĆ**Chief Prosecutor, Prosecutor's Office of Bosnia and Herzegovina**

Milanko Kajganić graduated from the Faculty of Law in Banja Luka in 2005 and passed the bar exam in 2008. From June 1994 to December 2006, he worked at the Ministry of Internal Affairs of Republika Srpska in various roles, including as a police officer, platoon commander, inspector in the Department for Combating the Production and Trafficking of Narcotic Drugs and, finally, as an inspector for internal control. From January 2007 to March 2014, he was employed at the Special Prosecutor's Office in Banja Luka. In March 2014, by decision of the High Judicial and Prosecutorial Council, he was appointed prosecutor at the Prosecutor's Office of Bosnia and Herzegovina, assuming the position the same month. He serves as a consultant for the OSCE in the field of criminal law and has acted as a trainer at several seminars organised or supported by the OSCE Mission to BiH, the BiH Ministry of Justice, and the FBiH Association of Judges, intended for judges, prosecutors, lawyers and police officers in BiH. He is a member of Bosnia and Herzegovina's negotiating team in the process of concluding the Cooperation Agreement between EUROJUST and BiH and speaks English.

SANIN BOGUNIĆ**President of the High Judicial and Prosecutorial Council**

Since 2002, Sanin Bogunić has worked in the judiciary in the positions of judicial trainee, legal associate and legal adviser at the Court of Bosnia and Herzegovina. By decision of the High Judicial and Prosecutorial Council (HJPC) of BiH in March 2008, he was appointed to the position of Prosecutor at the Cantonal Prosecutor's Office of the Sarajevo Canton. From January 2015 to December 2018, he served as Head of the Department for Economic Crime and Corruption at the Cantonal Prosecutor's Office of the Sarajevo Canton. Prosecutors from the cantonal prosecutor's offices in the Federation of BiH elected him as a member of the HJPC of BiH in July 2021, and he assumed the duties of a member in September 2021. In February 2025, he was elected President of the High Judicial and Prosecutorial Council of BiH, a position he currently holds.

PROF. PAYAM AKHAVAN**Professor of International Law; Human Rights Chair and Senior Fellow, Massey College, University of Toronto; former Special Advisor on Genocide to the ICC Prosecutor; former Legal Advisor, ICTY Office of the Prosecutor**

Payam Akhavan, is Professor of International Law, Senior Fellow and the inaugural holder of the Chair in Human Rights at Massey College, University of Toronto. He is also Member of the Permanent Court of Arbitration, Associate Member of the Institut de droit international, and a former Special Advisor on Genocide to the Prosecutor of the International Criminal Court. Professor Akhavan was previously Full Professor at McGill University Faculty of Law (2005-20), Distinguished Visitor at the University of Toronto Faculty of Law, and Fernand Braudel Senior Fellow at the European University Institute in Florence, with other appointments at Yale Law School, Leiden University, Oxford University, Université Paris Nanterre, Sciences Po École de Droit, and University of Fiji. In 2017 he delivered the CBC Massey Lectures in Canada. Professor Akhavan was the first Legal Advisor to the Prosecutor's Office of the International Criminal Tribunal for the former Yugoslavia (1994-2000) at The Hague. He has also served with the UN investigating atrocities in conflict zones – and defended genocide survivors throughout the world – including the Bahá'ís of Iran, the Yazidi of Iraq, and Myanmar's Rohingya minority.

MILANKO KAJGANIĆ**Glavni tužilac, Tužilaštvo Bosne i Hercegovine**

Milanko Kajganić je diplomirao na Pravnom fakultetu u Banjaluci 2005. godine, a pravosudni ispit je položio 2008. godine. U periodu od juna 1994. godine do decembra 2006. godine je radio u Ministarstvu unutrašnjih poslova Republike Srpske na raznim poslovima, od policajca, komandira voda, inspektora u Odjeljenju za suzbijanje proizvodnje i prometa opojnih droga i na kraju inspektora za unutrašnju kontrolu. U periodu od januara 2007. godine do marta 2014. godine je bio zaposlen u Specijalnom tužilaštvu u Banjaluci. Odlukom Visokog sudskog i tužilačkog vijeća je u martu 2014. godine imenovan na poziciju tužioca u Tužilaštvu BiH, koju je počeo obavljati istog mjeseca 2014. godine. Konsultant je organizacije OSCE iz oblasti krivičnog prava te je kao edukator učestvovao na više seminara organizovanih ili podržanih od strane Misije OSCE-a u BiH, Ministarstva pravde BiH i Udruženja sudija FBiH za sudije, tužioce, advokate i policijske službenike u BiH. Član je pregovaračkog tima Bosne i Hercegovine za proces pregovaranja Sporazuma o saradnji između EUROJUST-a i BiH te govori engleski jezik.

SANIN BOGUNIĆ**Predsjednik Visokog sudskog i tužilačkog vijeća**

Od 2002. godine Sanin Bogunić radio je u pravosuđu na pozicijama sudijskog pripravnika, pravnog saradnika i pravnog savjetnika u Sudu Bosne i Hercegovine. Odlukom VSTV-a BiH od marta 2008. godine imenovan je na poziciju tužioca u Kantonalnom tužilaštvu Kantona Sarajevo. U periodu od januara 2015. do decembra 2018. godine obavljao je dužnost šefa Odjela za privredni kriminalitet i korupciju Kantonalnog tužilaštva Kantona Sarajevo. Tužioci kantonalnih tužilaštava u Federaciji BiH izabrali su ga za člana VSTV-a BiH u julu 2021. godine te je dužnost člana preuzeo u septembru 2021. godine. U februaru 2025. godine izabran je za predsjednika Visokog sudskog i tužilačkog vijeća BiH koju funkciju trenutno obavlja.

PROF. PAYAM AKHAVAN**Profesor međunarodnog prava i viši saradnik na koledžu Massey, Univerzitet u Torontu, bivši specijalni savjetnik tužioca Međunarodnog krivičnog suda za predmete genocida i bivši pravnik savjetnik u uredu Tužilaštva MKSJ**

Payam Akhavan je profesor međunarodnog prava, viši saradnik i prvi rukovodilac Katedre za ljudska prava na Massey koledžu Univerziteta u Torontu. Takođe je član Stalnog arbitražnog suda, pridruženi član Instituta za međunarodno pravo (fr. Institut de droit international) i bivši specijalni savjetnik za genocid tužiocu Međunarodnog krivičnog suda. Profesor Akhavan je ranije bio redovni profesor na Pravnom fakultetu Univerziteta McGill (2005.–2020.godine), gostujući profesor na Pravnom fakultetu Univerziteta u Torontu i istaknuti istraživač u okviru programa Fernand Braudel pri Evropskom univerzitetskom institutu u Firenci, a obavljao je i druge angažmane na Pravnom fakultetu Univerziteta Yale, Univerzitetu Leiden, Univerzitetu Oxford, Univerzitetu Paris Nanterre, Pravnoj školi Sciences Po i Univerzitetu Fiji. Godine 2017. održao je prestižnu seriju javnih predavanja koja se svake godine održava u organizaciji medijske kuće Canadian Broadcasting Corporation (CBC) u saradnji s Massey College u Kanadi. Profesor Akhavan je bio prvi pravni savjetnik u Tužilaštvu Međunarodnog krivičnog suda za bivšu Jugoslaviju (1994–2000) u Hagu. Takođe je službovao u okviru UN-a istražujući zločine u ratnim zonama i zastupao preživjele žrtve genocida širom svijeta – uključujući Bahá'í zajednicu u Iranu, Jazide u Iraku i pripadnike Rohingya manjine u Mjanmaru.

DR. SERGE BRAMMERTZ**Chief Prosecutor, International Residual Mechanism for Criminal Tribunals**

Dr. Serge Brammertz is the Chief Prosecutor of the United Nations International Residual Mechanism for Criminal Tribunals (IRMCT). He is also the Vice-President of the Advisory Council of the International Nuremberg Principles Academy. Dr. Brammertz served as the Chief Prosecutor of the International Criminal Tribunal for the former Yugoslavia (ICTY), a role he has held since 2008. He has overseen the arrest and prosecution of key political and military leaders, including Radovan Karadžić and Ratko Mladić. From January 2006 to the end of 2007, Dr. Brammertz served as the Commissioner of the United Nations International Independent Investigation Commission into the murder of former Prime Minister of Lebanon Rafik Hariri. He previously was Deputy Prosecutor of the International Criminal Court (ICC), and he was the head of the Federal Prosecution of the Kingdom of Belgium, where he supervised numerous investigations and trials related to cases of organised crime, terrorism and violations of international humanitarian law.

PROF. ANGELIKA NUSSBERGER**Professor of International Law, Public Law and Comparative Law at the University of Cologne, International Judge and Vice-President, Constitutional Court of Bosnia and Herzegovina**

Angelika Nußberger is Professor of International Law, Public Law and Comparative Law at the University of Cologne and founding director of the Academy for European Human Rights Protection. She is also an international Judge and Vice-President of the Constitutional Court of Bosnia and Herzegovina, as well as the German Member of the Venice Commission of the Council of Europe. She was a Judge at the European Court of Human Rights from January 2011 to December 2019 and its Vice-President from February 2017 until the end of her term. She is also member of the Institut de Droit International and holds several honorary doctorates. Professor Nußberger has also been a member of the Independent International Fact-Finding Mission on the Conflict in Georgia and was special rapporteur under the Moscow mechanism of the OSCE on "Russia's Legal and Administrative Practice in Light of its OSCE Human Dimension Commitments". She studied law and literature in Munich, Würzburg, Moscow and Boston (as a visiting researcher at Harvard University 1994/1995), and worked at the Max-Planck-Institute for Foreign and International Social Law. Her notable publications include *The European Court of Human Rights* (Oxford University Press, 2000, second edition 2025) and *Die Menschenrechte. Geschichte, Philosophie, Konflikte* (Beck-Verlag, 2021).

PROF. PABLO DE GREIFF**Senior Fellow and Director, Transitional Justice Program at the Center for Human Rights and Global Justice of the School of Law at NYU, founding United Nations Special Rapporteur on the promotion of truth, justice, reparation and guarantees of non-recurrence**

Professor Pablo de Greiff is Senior Fellow and Director of the Transitional Justice Program and of the Prevention Project at the Center for Human Rights and Global Justice of the School of Law at New York University. He previously was the Director of Research at the International Center for Transitional Justice from 2001 to 2014. In 2012, Mr de Greiff was appointed as the first UN Special Rapporteur on the promotion of truth, justice, reparation, and guarantees of non-recurrence, a position he held until May 2018. In January 2015 he was also appointed by the High Commissioner for Human Rights to be part of UNIIB, a mission of Independent Experts to address the situation in Burundi. In December 2018 he was appointed by the President of the UN Human Rights Council as a Rapporteur in the group of experts to advise the Council on its prevention role. Since March 2022, he has been one of the three Commissioners of the UN's Independent Commission of Inquiry on Ukraine. Mr de Greiff has provided advice to a wide range of governments, the UN and non-governmental organisations, particularly victims' organisations, truth commissions and multilateral institutions in the fields of transitional justice, gender issues and the linkages between justice, security and development. He has taught extensively, including at Yale, Harvard, Oxford, Columbia, Cornell and the European University Institute.

DR. SERGE BRAMMERTZ**Glavni tužilac, Međunarodni rezidualni mehanizam za krivične sudove**

Dr. Serge Brammertz je glavni tužilac Međunarodnog rezidualnog mehanizma za krivične sudove pri Ujedinjenim narodima (IRMCT). Takođe je potpredsjednik Savjetodavnog vijeća Međunarodne akademije nürnbergskih principa. Dr. Brammertz je obavljao funkciju glavnog tužioca Međunarodnog krivičnog suda za bivšu Jugoslaviju (MKSJ), na kojoj je bio od 2008. godine. Nadzirao je hapšenje i procesuiranje ključnih političkih i vojnih lidera, uključujući Radovana Karadžića i Ratka Mladića. U periodu od januara 2006. do kraja 2007. godine, dr. Angelika Nußberger je profesorica međunarodnog prava, javnog prava i komparativnog prava na Univerzitetu u Kelnu te prva direktorica Akademije za zaštitu evropskih ljudskih prava. Takođe je i međunarodna sutkinja i potpredsjednica Ustavnog suda Bosne i Hercegovine te njemačka članica Venecijanske komisije Vijeća Evrope. Bila je sutkinja na Evropskom sudu za ljudska prava od januara 2011. do decembra 2019. godine, a potpredsjednica tog suda od februara 2017. do kraja svog mandata. Članica je Instituta za međunarodno pravo (fr. *Institut de droit international*) i posjeduje nekoliko počasnih doktorata. Bila je članica Nezavisne međunarodne misije za utvrđivanje činjenica o sukobu u Gruziji i posebna izjaviteljica po Moskovskom mehanizmu OSCE-a za "Pravnu i administrativnu praksu Rusije u svjetlu njenih OSCE obaveza u oblasti ljudskih prava". Studirala je pravo i književnost u Münchenu, Würzburgu, Moskvi i Bostonu (kao gostujuća istraživačica na Harvardskom univerzitetu 1994/1995. godine) te radila u Institutu Max-Planck za strano i međunarodno društveno pravo. Džidić has worked as a journalist since 2006, starting his career in Oslobođenje, a daily newspaper from Bosnia and Herzegovina. He joined BIRN in August 2008 and has guided the newsroom in building one of the most comprehensive war crime reporting archives in the region. Panel 1

Prosecuting Genocide Denial: Strategies and Challenges

The first panel will examine approaches and experiences most pertinent to the investigation and prosecution of genocide denial in different jurisdictions. In this context, the discussants will explore the regulations, case-law and established practices emanating from various legal systems. The panellists will further examine the role of legal norms more broadly in discouraging genocide denial on individual and societal levels and in furthering prevention. In relation to the Bosnian experience the panel discussions will also take stock on the status quo after the introduction of the amendments and identify steps required to further overcome challenges hindering the prosecution of denial in the current context.

DAVID BECK

Commissioner, Bavarian Judiciary for Combating Hate Speech

David Beck is a public prosecutor. As head of a group within the General Prosecutor's Office in Munich, he has been appointed Hate Speech Commissioner to the Bavarian judiciary as of February 2024. Previously, he was a prosecutor with the Prosecutor's Office in Kempten and a judge at the district court (Landgericht) in Kempten, dealing – among other matters – with hate and organised crime. David Beck currently coordinates and supports the work of 22 specialised local prosecutors in dealing with online hate crime in various forms, including Holocaust and genocide denial. Furthermore, he conducts high-profile investigations with his hate speech team of three other prosecutors at the General Prosecutor's Office in Munich.

NEDIM ĆOSIĆ

Prosecutor at the Prosecutor's Office of Bosnia and Herzegovina

Nedim Ćosić holds a law degree and has over 20 years of experience in the judiciary. He is currently serving as a Prosecutor in the Special Department for Organised Crime, Economic Crime, and Corruption, within the Section for International Legal Assistance and Other Criminal Offences, including the prosecution of criminal offences against human and civil rights and freedoms. He spent most of his career at the Municipal Court in Sarajevo as a criminal law judge, handling cases related to general crime, economic crime and corruption, and served as Head of the Small Claims Division from 2013 to 2023. From 2006 to 2013, he worked as a legal associate in the land registry and as a judicial associate at the Municipal Court in Sarajevo. He has participated in numerous seminars and professional training sessions at the local, regional and international levels. He has been a member of various bodies within several professional judicial associations. Mr. Ćosić has published scientific articles and worked as a lecturer and presenter at professional conferences and round tables. He has also served as a legal consultant in Bosnia and Herzegovina and as an international legal expert abroad.

Panel 1

Procesuiranje negiranja genocida: Strategije i izazovi

Na prvom panelu će biti razmatrani pristupi i iskustva koji su najrelevantniji za istraživanje i procesuiranje negiranja genocida u različitim pravnim sistemima/ jurisdikcijama. U tom kontekstu, učesnici će analizirati relevantne propise, sudsku praksu i ustaljene prakse koje proizlaze iz različitih pravnih sistema. Panelisti će dodatno ispitati ulogu pravnih normi u širem smislu u suzbijanju negiranja genocida – kako na individualnom, tako i na širem društvenom planu te u smislu unapređenja prevencije. U pogledu bosanskohercegovačkog iskustva, u okviru panel diskusija takođe će biti izrađen pregled stanja nastalog nakon donošenja izmjena i dopuna zakona te utvrđeni potrebni koraci za daljnje prevazilaženje prepreka koje otežavaju procesuiranje negiranja u sadašnjim okolnostima.

DAVID BECK

Povjerenik bavarskog pravosuđa zadužen za borbu protiv govora mržnje

David Beck je javni tužilac. Kao šef grupe pri Uredu glavnog tužioca u Minhenu, od februara 2024. imenovan je na poziciju povjerenika bavarskog pravosuđa zaduženog za borbu protiv govora mržnje. Ranije je radio kao tužilac u Tužilaštvu u Kemptenu i kao sudija na okružnom sudu (njem. *Landgericht*) u Kemptenu, gdje se između ostalog bavio i predmetima govora mržnje i organiziranog kriminala. David Beck trenutno koordinira i pruža podršku radu 22 specijalizirana lokalna tužioca u procesuiranju različitih vidova krivičnih djela počinjenih iz mržnje na internetu, uključujući i negiranje Holokausta i genocida. Pored toga, osobno vodi istrage od velikog značaja sa svojim timom zaduženim za borbu protiv govora mržnje, koji čine još tri tužioca u Uredu glavnog tužioca u Minhenu.

NEDIM ĆOSIĆ

Tužilac Tužilaštva Bosne i Hercegovine

Nedim Ćosić je diplomirani pravnik sa više od 20 godina iskustva rada u pravosuđu. Trenutno obnaša funkciju tužioca Tužilaštva Bosne i Hercegovine u Posebnom odjelu za organizirani kriminal, privredni kriminal i korupciju, Odsjek za međunarodnu pravnu pomoć i druga krivična djela, uključujući procesuiranje krivičnih djela protiv slobode i prava čovjeka i građanina. Veći dio svoje karijere je proveo radeći u Općinskom sudu u Sarajevu kao sudija na krivičnom referatu postupajući u predmetima općeg kriminala, privrednog kriminala i korupcije, te kao predsjednik Odjeljenja za sporove male vrijednosti u periodu 2013.-2023. godine. Obavljao je poslove stručnog saradnika za vođenje zemljišnih knjiga i poslove sudskog stručnog saradnika u Općinskom sudu u Sarajevu u periodu 2006.-2013. godine. Učesnik je većeg broja seminara i stručnih obuka u zemlji, regionu i inostranstvu. G. Ćosić je takođe bio član u organima više profesionalnih udruženja u pravosuđu. Objavljivao je naučne radove, bio predavač i prezentator na stručnim skupovima i okruglim stolovima. Obavljao je poslove pravnog konsultanta u zemlji i poslove međunarodnog pravnog eksperta u inostranstvu.

NIVES KANEVČEV

Prosecutor, Head of the Section for International Legal Assistance and Other Criminal Offences within the Competence of the Prosecutor's Office of Bosnia and Herzegovina

In her professional career, starting in 1998, Prosecutor Kanevčev served as Deputy Prosecutor at the Municipal Prosecutor's Office I in Sarajevo. In 2003, she was appointed Prosecutor at the Cantonal Prosecutor's Office in Sarajevo, and in 2009 she became Chief Prosecutor at the same office. In 2015, she was appointed Prosecutor at the Prosecutor's Office of Bosnia and Herzegovina, and she currently serves as Head of the Section for International Legal Assistance and Other Criminal Offences within the jurisdiction of the Prosecutor's Office of BiH. During this period, as Prosecutor, she handled cases in the fields of war crimes, corruption, organised crime, economic crime, as well as cases under Chapter XV of the Criminal Code of BiH – criminal offenses against human and civil freedoms and rights (Provoking Ethnic, Racial and Religious Hatred, Conflicts and Intolerance – Article 145a), Election Forgery – Article 154, and other criminal offenses. She is a member of the Association of Prosecutors of the Prosecutor's Office of BiH, and throughout her career, as a lecturer and participant, she has attended numerous seminars, training courses and conferences.

MARJORIE MASSELOT

Judge, Kosovo Specialist Chambers

Judge Marjorie Masselot has served as a Presiding Judge at the Colmar First Instance Criminal Court since 2019, where she deals with organised crime and sexual crimes. Since 2023, Judge Masselot has also been seconded to the Ministry of Justice of France as a Deputy Head of the Office for Institutional and Diplomatic Affairs within the Delegation for European and International Affairs. From 2017 to 2019, Judge Masselot served as a prosecutor at the Criminal Court of Verdun. Earlier in her career, Judge Masselot held various legal officer positions at the War Crimes Chamber of the State Court of Bosnia and Herzegovina from 2006 to 2008, at the United Nations Criminal Tribunal for Rwanda from 2008 to 2009 and at the International Criminal Court from 2009 to 2015. Judge Masselot holds three post-graduate Master's degrees in law from the Law University of Aix-en-Provence and the University of Strasbourg. She has published and lectured in the field of international criminal law.

DR. GURGEN PETROSSIAN

Senior Officer for International Criminal Law, International Nuremberg Principles Academy

Dr. Gurgen Petrossian is Senior Officer for International Criminal Law at the International Nuremberg Principles Academy. He holds teaching positions at Friedrich-Alexander Universität Erlangen-Nürnberg (FAU), Katholische Universität Eichstätt-Ingolstadt and Yerevan State University. Before rejoining the Nuremberg Academy, Mr Petrossian advised one of Germany's largest textile companies on matters of business and human rights in accordance with the German Act on Due Diligence in Supply Chains. Previously, he served as Head of the International Criminal Law Research Unit at FAU. During his tenure, he led research projects funded by the German Federal Foreign Office and the German Research Foundation on topics such as "Length of Proceedings at the International Criminal Court" and "Victims' Rights before the International Criminal Court". He has provided assistance to the Republic of Armenia and the Iraqi Kurdistan Autonomous Region in incorporating international criminal law into their respective legal systems. Additionally, he gained valuable experience at the Ministry of Justice of the Republic of Armenia. Dr Petrossian obtained an LLB from Yerevan State University and an LLM from Universität Heidelberg and earned a PhD from FAU. He publishes on international criminal law, international law and human rights. Since 2019-2025, he has been the president of the German-Armenian Lawyers' Association and a member of the German Institute for Compliance.

NIVES KANEVČEV

Tužiteljica, šefica Odsjeka za međunarodnu pravnu pomoć i ostala krivična djela iz nadležnosti Tužilaštva Bosne i Hercegovine

U svojoj profesionalnoj karijeri tužiteljica Kanevčev je počevši od 1998. godine obavljala dužnost zamjenice tužitelja u Općinskom tužiteljstvu I u Sarajevu. Godine 2003. imenovana je za tužiteljicu u Kantonalnom tužiteljstvu u Sarajevu, a 2009. godine imenovana je za glavnu tužiteljicu u Kantonalnom tužiteljstvu u Sarajevu. Godine 2015. imenovana je za tužiteljicu u Tužiteljstvu Bosne i Hercegovine, te je trenutno na poziciji šefice Odsjeka za međunarodnu pravnu pomoć i ostala kaznena djela iz nadležnosti Tužiteljstva BiH. U navedenom razdoblju kao tužiteljica postupala je u predmetima iz oblasti ratnih zločina, korupcije, organiziranog kriminala, privrednog kriminala, te predmetima iz glave XV KZ BiH- kaznena djela protiv slobode i prava čovjeka i građanina (izazivanje nacionalne, rasne i vjerske mržnje, razdora i netrpeljivosti- član 145a), Izborne prijevare- član 154. i druga kaznena djela. MARJORIE MASSELOT

Sutkinja, Specijalizovana vijeća Kosova

Sutkinja Marjorie Masselot obavlja dužnost predsjedavajuće sutkinje na Prvostepenom krivičnom sudu u Kolmaru od 2019. godine, gdje se bavi organiziranim kriminalom i seksualnim deliktima. Od 2023. godine, sutkinja Masselot radi na poziciji sutkinje privremeno delegirane u Ministarstvo pravde Francuske, gdje vrši dužnost zamjenice načelnika Ureda za institucionalne i diplomatske poslove pri Delegaciji za evropske i međunarodne poslove. U periodu od 2017. do 2019. godine sutkinja Masselot je radila kao tužiteljica na Krivičnom sudu u Verdunu. Prije toga, u svojoj karijeri je obavljala različite funkcije pravne službenice u Odjelu za ratne zločine Državnog suda Bosne i Hercegovine u periodu od 2006. do 2008. godine, na Međunarodnom krivičnom sudu za Ruandu u periodu od 2008. do 2009. godine, te na Međunarodnom krivičnom sudu u periodu od 2009. do 2015. godine. Sutkinja Masselot posjeduje tri postdiplomska magistarska stepena iz prava, stečena na Pravnom fakultetu u Aix-en-Provence i Univerzitetu u Strazburu. Objavljivala je radove i predavala na polju međunarodnog krivičnog prava.

DR. GURGEN PETROSSIAN

Viši službenik za međunarodno krivično pravo, Međunarodna akademija nürnbergskih principa

Dr. Gurgen Petrossian je viši službenik za međunarodno krivično pravo pri Međunarodnoj akademiji nürnbergskih principa. Predaje na Friedrich-Alexander Univerzitetu Erlangen-Nürnberg (FAU), Katoličkom univerzitetu Eichstätt-Ingolstadt i Državnom univerzitetu u Jerevanu. Prije ponovnog angažmana u Nürnbergskoj akademiji, g. Petrossian je savjetovao jednu od najvećih njemačkih tekstilnih kompanija o pitanjima vezanim za poslovanje i ljudska prava u skladu s njemačkim Zakonom o savjesnom postupanju u lancima opskrbe. Ranije je radio kao rukovodilac Istraživačke jedinice za međunarodno krivično pravo na FAU. Tokom svog mandata, vodio je istraživačke projekte koje su finansirali Savezno ministarstvo vanjskih poslova Njemačke i Njemačka fondacija za istraživanje, na teme poput *"Dužina trajanja postupaka pred Međunarodnim krivičnim sudom"* i *"Prava žrtava pred Međunarodnim krivičnim sudom"*. Pružao je pomoć Republici Armeniji i Autonomnoj regiji Irački Kurdistan u uvođenju međunarodnog krivičnog prava u njihove pravne sisteme. Pored toga, stekao je dragocjeno iskustvo u Ministarstvu pravde Republike Armenije. Dr. Petrossian je diplomirao pravo na Državnom univerzitetu u Jerevanu, završio magisterij prava na Univerzitetu Heidelberg, te doktorirao na FAU. Objavljuje radove iz oblasti međunarodnog krivičnog prava, međunarodnog prava i oblasti ljudskih prava. Od 2019. do 2025. godine predsjednik je Njemačko-armenskog udruženja pravnika i član Njemačkog instituta za usklađenost.

Panel 2

Protecting Freedom of Expression and Protection from Hate Speech

The prosecution of genocide denial has an understandably delicate interaction with the need to ensure fundamental protections regarding freedom of expression. The second panel will explore this interaction while delving into international and domestic frameworks regulating freedom of expression and hate speech both in online and offline domains. The discussions will note the importance of adopting legal provisions that respect the historical intricacies, political fault lines and individual identities shaping different contexts. The panellists will further delve into the impact of social media and artificial intelligence in furthering denial and assess international law frameworks governing both online hate speech and protecting civil and political rights in this context.

ANNA AUSTIN

Jurisconsult, European Court of Human Rights

Anna Austin has worked with the Council of Europe for the last 30 years. Formerly a solicitor in Dublin, she joined the European Commission on Human Rights in 1994 and the European Court of Human Rights in 1998. Appointed Deputy Jurisconsult in 2015, she became Jurisconsult of the Court in 2020. In this position, she also worked to develop and launch in 2022 the ECHR Knowledge Sharing platform. Ms. Austin has combined her work with several secondments as Deputy Ombudsperson for Bosnia and Herzegovina, Head of the Office of the Investigating Judges of the Khmer Rouge Tribunal in Cambodia, Advisor to the CoE Committee of Ministers and Legal Advisor to the International Advisory Panel on Ukraine.

DR. TALITA DIAS

International Policy and Government Lead, Partnership on AI

Dr Talita Dias is the International Policy and Government Lead at Partnership on AI (PAI). She leads PAI's government relations and research on global AI governance. Prior to joining PAI, she was the Senior Research Fellow in the International Law Programme at Chatham House – The Royal Institute of International Affairs, leading research on how international law applies to new technologies, including cyber, online platforms and artificial intelligence. Dr. Dias is an international lawyer with over a decade of combined policy and research experience, including in international human rights law, humanitarian law and criminal law. She is the author of *Beyond Imperfect Justice* and the co-author of the *Handbook on Developing a National Position on International Law and Cyber Activities*. She holds a DPhil and Master's degree in law from Oxford University, and a Bachelor of Laws from the Federal University of Pernambuco in Brazil, where she is also qualified lawyer.

Panel 2

Zaštita slobode izražavanja i zaštita od govora mržnje

Razumljivo je da je procesuiranje negiranja genocida na delikatan način uzajamno povezano s potrebom da se osigura temeljna zaštita slobode izražavanja. Na drugom panelu razmatrat će se ta uzajamna povezanost, pri čemu će se detaljnije analizirati međunarodni i domaći pravni okviri kojima se reguliraju sloboda izražavanja i govor mržnje, kako u elektronskim tako i u tradicionalnim medijima. U diskusijama će se naglasiti važnost donošenja pravnih odredbi kojima se poštuju historijske složenosti, političke linije razilaženja i individualni identiteti koji oblikuju različite kontekste. Panelisti će dodatno istražiti utjecaj društvenih mreža i umjetne inteligencije na širenje negiranja te procijeniti okvire međunarodnog prava kojima se uređuje kako govor mržnje na internetu tako i zaštita građanskih i političkih prava u ovom kontekstu.

ANNA AUSTIN

Glavna stručna pravna savjetnica (jurisconsult) za tumačenje i primjenu Evropske konvencije pri Evropskom sudu za ljudska prava

U periodu od proteklih 30 godina Anna Austin je radila za Vijeće Evrope. Prije toga je radila kao pravica u Dublinu, a pridružila se Evropskoj komisiji za ljudska prava 1994. godine, te Evropskom sudu za ljudska prava 1998. godine. Od 2015. godine je bila na poziciji zamjenice glavnog stručnog pravnog savjetnika za tumačenje i primjenu Evropske konvencije pri Evropskom sudu za ljudska prava (engl. *Deputy Jurisconsult*), a 2020. imenovana je za glavnu stručnu pravnu savjetnicu ovog Suda (engl. *Jurisconsult*). Na toj poziciji je također radila na izradi i pokretanju platforme za razmjenu znanja o Evropskoj konvenciji o ljudskim pravima (engl. *ECHR Knowledge Sharing platform*) u 2022. godini. Gđa Austin je svoj redovni rad kombinirala sa nekoliko pozicija na koje je bila privremeno delegirana, uključujući i funkcije zamjenice Ombudsmana za Bosnu i Hercegovinu, rukovoditeljice Ureda istražnih sudija pri specijalnom sudu osnovanom za procesuiranje zločina počinjenih za vrijeme režima Crvenih Khmera u Kambodži, savjetnice Odbora ministara pri Vijeću Evrope i pravne savjetnice Međunarodnog savjetodavnog panela za Ukrajinu.

DR. TALITA DIAS

Voditeljica programa za međunarodnu politiku i saradnju s vladama, Partnerstvo za umjetnu inteligenciju

Dr Talita Dias je voditeljica programa za međunarodnu politiku i saradnju s vladama u organizaciji Partnerstva za umjetnu inteligenciju (engl. *Partnership on AI*, skr. PAI). Voditeljica je programa ovog partnerstva u oblasti saradnje s vladama i istraživanja o globalnom upravljanju umjetnom inteligencijom. Prije svog angažmana u partnerstvu PAI, Talita je bila viša naučna saradnica u programu međunarodnog prava u nezavisnom istraživačkom centru Chatham House – pri Kraljevskom institutu za međunarodne odnose, gdje je vodila istraživanja o primjeni međunarodnog prava na nove tehnologije, uključujući kibernetički prostor, internetske platforme i umjetnu inteligenciju. Dr. Dias je međunarodna pravica sa više od decenije kombiniranog iskustva u oblastima politike i istraživanja, uključujući i oblasti poput međunarodnih ljudskih prava, humanitarnog i krivičnog prava. Autorica je knjige *Prevazilazeći nesavršenu pravdu* (engl. orig. *Beyond Imperfect Justice*) i koautorica *Priručnika za formiranje stavova država o međunarodnom pravu i kibernetičkim aktivnostima* (engl. *the Handbook on Developing a National Position on International Law and Cyber Activities*). Dr. Dias posjeduje doktorat (DPhil) i magistarsku diplomu iz pravnih nauka sa Univerziteta u Oksfordu, kao i diplomu diplomiranog pravnika sa Saveznog univerziteta Pernambuco u Brazilu, gdje je također kvalificirana pravica.

D.JUR. LJILJANA FILIPOVIĆ**Judge, Supreme Court of the Federation of Bosnia and Herzegovina**

Judge Ljiljana Filipović graduated from law school, earned her Master's degree in law (with a thesis on "Criminal Law and Criminological Aspects of Human Trafficking"), and obtained her PhD in law (with a dissertation on "The Identity of Judgment and Indictment") at the Faculty of Law, University of Sarajevo. She has been serving as a judge since 1983 and has been a judge of the Supreme Court of the Federation of Bosnia and Herzegovina since 2003. Since 2018, she has been the President of the Criminal Department of the Supreme Court of the Federation of Bosnia and Herzegovina. She is the author of several scholarly papers in the field of criminal law, including works on hate crimes and criminal offenses related to provoking hatred and hostility. She is a member of several working groups responsible for drafting legislation in the field of criminal law. She also serves as a trainer at the Judicial and Prosecutorial Training Centre in the Federation of Bosnia and Herzegovina.

PROF. DR. ALMIR MALJEVIĆ**Professor of Criminal Law, University of Sarajevo**

Professor Dr. Almir Maljević completed his undergraduate studies at the Faculty of Criminal Justice Sciences, University of Sarajevo (1996–2000), and obtained his Master of Laws in Criminal Law from the Faculty of Law, University of Mostar in 2005. Supported by a DAAD scholarship, he earned his Doctor of Juridical Sciences degree at the Albert-Ludwigs-Universität Freiburg in 2009, within the framework of the International Max Planck Research School for Comparative Criminal Law (IMPRS-CC). A faculty member since 2001, he is currently a tenured Professor of Criminal Law at the Faculty of Criminal Justice Sciences, University of Sarajevo. Over the past two decades, his scholarly work has focused on various forms of organised crime and associated phenomena, including corruption, money laundering and related criminal justice responses. His research integrates comparative, interdisciplinary, and policy-oriented perspectives, with an emphasis on bridging academic scholarship and practical application in the fight against complex criminal activities.

DR. SC. LJILJANA FILIPOVIĆ**Sutkinja, Vrhovni sud Federacije Bosne i Hercegovine**

Sutkinja Ljiljana Filipović je diplomirala, magistrirala (na temu *"Krivičnopravni i kriminološki aspekti trgovine ljudima"*) i doktorirala (na temu *"Identitet presude i optužbe"*) na Pravnom fakultetu Univerziteta u Sarajevu. Sutkinja je od 1983. godine, a od 2003. godine sutkinja je Vrhovnog suda Federacije Bosne i Hercegovine. Od 2018. godine, predsjednica je Krivičnog odjeljenja Vrhovnog suda Federacije Bosne i Hercegovine. Autorica je više radova iz krivičnopravne oblasti, između ostalog i o krivičnim djelima iz mržnje i krivičnim djelima izazivanja mržnje i netrpeljivosti. Članica je više radnih grupa nadležnih za izradu zakona iz krivičnopravne oblasti. Edukatorica je u Centru za edukaciju sudija i tužitelja u Federaciji Bosne i Hercegovine.

PROF. DR. ALMIR MALJEVIĆ**Profesor krivičnog prava, Univerzitet u Sarajevu**

Profesor dr. Almir Maljević završio je dodiplomske studije na Fakultetu za kriminalističke nauke Univerziteta u Sarajevu (1996.–2000. godine), a 2005. godine stekao je zvanje magistra pravnih nauka iz oblasti krivičnog prava na Pravnom fakultetu Univerziteta u Mostaru. Uz podršku DAAD stipendije, 2009. godine stekao je akademsko zvanje doktora pravnih nauka na Univerzitetu Albert-Ludwigs-Universität u Freiburgu, u okviru Međunarodne istraživačke škole Instituta Max Planck za komparativno krivično pravo (IMPRS-CC). Član je nastavnog osoblja fakulteta od 2001. godine, a trenutno je redovni profesor krivičnog prava na Fakultetu kriminalističkih nauka Univerziteta u Sarajevu. Tokom protekle dvije decenije njegov naučno-istraživački rad fokusiran je na različite vidove organiziranog kriminala i prateće pojave, uključujući korupciju, pranje novca i s njima povezane krivičnopravne mehanizme odgovora. Njegova istraživanja objedinjuju komparativne, interdisciplinarne i perspektive usmjerene na kreiranje politika, s naglaskom na povezivanju rezultata akademskog istraživanja i njihove praktične primjene u suzbijanju složenih oblika kriminaliteta.

Panel 3

From Legal Inaction to a Culture of Impunity and Denial

The final panel will highlight the enduring and pervasive impact of denial on victims and societies, including on initiatives furthering recognition and reconciliation. The panel will especially incorporate the perspectives of survivor groups and civil society in this regard and highlight the importance of anti-denial measures and education to prevention and guarantees of non-repetition. The panellists will also assess how such measures strengthen democratic values and institutions while identifying the fault lines that impede their effective implementation. Finally, the discussions will also explore the importance of memory laws, education and other initiatives constructing collective memory for furthering the right to truth, remedy and redress for victims.

HONORÉ GATERA

Director, Kigali Genocide Memorial

Honoré Gatera has contributed to various projects related to the preservation of the memory of the Genocide against the Tutsi and has participated in training on genocide prevention, education for the prevention of genocide, conflict resolution and peace building in England, the USA, Germany and Poland. He has travelled around the world, participating in conferences and meetings to raise awareness of genocide, its sad past and the threat it poses to humanity. Since 2010, he has served as the Director of the Kigali Genocide Memorial on behalf of the Aegis Trust.

ZLATAN HAJLOVAC

Project Manager, ProPeace Bosnia and Herzegovina

Zlatan Hajlovac is a Project Manager at ProPeace BiH. With experience in transitional justice, he has worked with several civil society organisations and previously served as a Project Manager at the Srebrenica-Potočari Memorial Center. He holds a Master's degree in Human Rights and Democracy in South East Europe from the University of Sarajevo and the University of Bologna, where his research focused on missing persons and war crimes in Bosnia and Herzegovina and Croatia.

Panel 3

Od pravne pasivnosti do kulture nekažnjivosti i negiranja

Na završnoj panel diskusiji će biti naglašen trajni i sveprisutni uticaj negiranja na žrtve i društva, uključujući i inicijative kojima se podržava priznavanje i pomirenje. Na ovom panelu će posebno biti obrađena stanovišta grupacija preživjelih žrtava i organizacija civilnog društva u tom kontekstu, te će biti naglašen značaj koji mjere protiv negiranja i obrazovanje imaju u prevenciji i garancijama za sprečavanje ponavljanja. Panelisti će takođe procijeniti kako takve mjere jačaju demokratske vrijednosti i institucije, uz identificiranje linija razilaženja koje ometaju njihovu efikasnu primjenu. Na kraju, kroz diskusije će se istražiti i značaj zakonâ o sjećanju, obrazovanja i drugih inicijativa za izgradnju kolektivnog sjećanja, u cilju ostvarivanja prava na istinu, pravnu zaštitu i reparaciju za žrtve.

HONORÉ GATERA

Direktor, Memorijalni centar za žrtve genocida u Kigaliju

Honoré Gatera je dao doprinos u različitim projektima vezanim za očuvanje sjećanja na genocid nad narodom Tutsi u Ruandi i učestvovao je na obukama vezanim za prevenciju genocida, obrazovanje usmjereno ka sprečavanju genocida, rješavanju konflikta i izgradnji mira u Engleskoj, SAD-u, Njemačkoj i Poljskoj. Putovao je širom svijeta, učestvujući na konferencijama i sastancima s ciljem podizanja svijesti o genocidu, njegovoj tužnoj prošlosti i prijetnji koju genocid predstavlja za čovječanstvo. Od 2010. godine, obavljao je funkciju direktora Memorijalnog centra za žrtve genocida u Kigaliju u ime organizacije Aegis Trust.

ZLATAN HAJLOVAC

Projektni menadžer, međunarodna organizacija ProPeace Bosnia and Hercegovina

Zlatan Hajlovac je projektni menadžer u međunarodnoj organizaciji ProPeace BiH. Uz iskustvo u oblasti tranzicijske pravde, g. Hajlovac je radio u nekoliko organizacija civilnog društva, a ranije je obavljao funkciju projektnog menadžera u Memorijalnom centru Srebrenica-Potočari. Zlatan Hajlovac magistrirao je ljudska prava i demokratiju u jugoistočnoj Evropi na Univerzitetu u Sarajevu i Univerzitetu u Bolonji, pri čemu je njegovo istraživanje bilo fokusirano na nestale osobe i ratne zločine u Bosni i Hercegovini i Hrvatskoj.

NATIA NAVROUZOV**Executive Director, Yazda**

Natia Navrouzov is the Executive Director of Yazda, a global NGO established in response to the 2014 ISIS genocide against the Yazidi community in Sinjar. A French-qualified lawyer and member of the Yazidi community, she specialises in international law, human rights, and transitional justice. Since joining Yazda in 2018, Natia has held several leadership roles, including Project Manager, Interim Country Director and Legal Advocacy Director. Under her leadership, Yazda has collected survivor testimonies, documented crime scenes and collaborated with international bodies such as UNITAD, national war crimes units and the Office of Amal Clooney, contributing to landmark convictions of ISIS members in Germany, including for genocide. She played a key role in establishing the Yazidi Survivors Network and advocating for the Yazidi Survivors Law, adopted in 2021. Previously, she worked at a leading international law firm in Paris, served as a Research Assistant at the London Court of Arbitration, and taught at Paris 1 Panthéon-Sorbonne. Admitted to the Paris Bar, Natia holds a dual bachelor's degree in German and French Law (University of Cologne and Paris 1), and a Master's degrees from Paris 1 and Columbia University, where she was a Fulbright and Human Rights Fellow and received the Davis Polk Fellowship. She is also an Obama Foundation Leader.

DR. EMIR SULJAGIĆ**Director, Srebrenica-Potočari Memorial Center, Bosnia and Herzegovina**

Dr. Emir Suljagić is the Director of the Srebrenica-Potočari Memorial Center. He holds a Master's degree in Democracy and Human Rights, awarded jointly by the University of Sarajevo and the University of Bologna in 2005 and a PhD in Political Science from the Institute for Peace Research and Security Studies at the University of Hamburg in 2010. During the war in Bosnia and Herzegovina, Dr. Suljagić served as an interpreter for the United Nations forces stationed in Srebrenica during the war in Bosnia and Herzegovina, an experience that enabled him to survive the Srebrenica genocide. He is the author of several books and memoirs, most notably *Postcards from the Grave* (Saqi Books, 2005), which has been translated into nine languages.

DR. CHRISTOPH THONFELD**Deputy Director and Director of the Research Department, Dachau Concentration Camp Memorial Site**

Christoph Thonfeld is Deputy Director and Head of the Research Department at Dachau Concentration Camp Memorial Site. He is a historian and has conducted research and taught at Bremen University, Hagen University, and Trier University (Germany), at Cheng Chi University and National Taiwan Normal University (both Taiwan/ROC) and at University College London (UK). His main areas of interest are 20th century German and European history (particularly Nazi era and its aftermath), diachronic analysis of survivor testimonies, and perpetrator research. His most recent book (co-authored with Peter Davies, Hannah Holtschneider, and Sheila Jelen) is titled *Olga Lengyel, Auschwitz survivor. Interdisciplinary explorations* (Palgrave Macmillan 2025).

DR. EMIR SULJAGIĆ**Direktor, Memorijalni centar Srebrenica-Potočari, Bosna i Hercegovina**

Dr. Emir Suljagić je direktor Memorijalnog centra Srebrenica-Potočari. Magistrirao je demokratiju i ljudska prava na Univerzitetu u Sarajevu i Univerzitetu u Bolonji 2005. godine, a doktorirao političke nauke na Institutu za istraživanje mira i sigurnosne studije Univerziteta u Hamburgu 2010. godine. Tokom rata u Bosni i Hercegovini radio je kao prevodilac za snage Ujedinjenih naroda stacionirane u Srebrenici, zahvaljujući čemu je preživio genocid u Srebrenici. Autor je nekoliko knjiga i memoara, među kojima se posebno ističe djelo *Razglednice iz groba* (engl. *Postcards from the Grave*, Saqi Books, 2005), koja je prevedena na devet jezika.

NATIA NAVROUZOV**Izvršna direktorica, Yazda**

Natia Navrouzov je izvršna direktorica organizacije Yazda, globalne nevladine organizacije osnovane kao odgovor na genocid kojeg je 2014. godine ISIS počinio nad etno-religijskom zajednicom Jezida u Sinjaru. Kao pravica kvalificirana u Francuskoj i članica jezidske zajednice, specijalizirala se za međunarodno pravo, ljudska prava i tranzicijsku pravdu. Od kada se pridružila Yazdi 2018. godine, Natia je obavljala nekoliko rukovodnih funkcija, uključujući funkcije projektne menadžerice, vršiteljice dužnosti državne direktorice i direktorice za pravnu advokaciju. Pod njenim rukovodstvom, Yazda je prikupila svjedočenja preživjelih, dokumentirala mjesta zločina i sarađivala s međunarodnim tijelima poput UNITAD-a, nacionalnih odjela za ratne zločine i Ureda Amal Clooney, doprinoseći ključnim presudama protiv članova ISIS-a u Njemačkoj, uključujući i presude za genocid. Igrala je ključnu ulogu u osnivanju Mreže preživjelih Jezida i zagovaranju Zakona o preživjelim Jezidima, usvojenog 2021. godine. Ranije je radila u jednoj od vodećih međunarodnih advokatskih kancelarija u Parizu, bila istraživačka asistentica na Londonskom arbitražnom sudu i predavala na Pariškom sveučilištu - Paris 1 Panthéon-Sorbonne. Kao članica Advokatske komore Pariza, Natia je stekla dvostruko dodiplomsko zvanje iz njemačkog i francuskog prava (Univerzitet u Kölnu i Paris 1), a magistrirala je na Paris 1 i Columbia University, gdje je bila stipendistica programa *Fulbright and Human Rights* te dobitnica *Davis Polk Fellowship* stipendije. Takođe je i liderica u okviru fondacije Obama Foundation.

DR. CHRISTOPH THONFELD**Zamjenik direktora i šef Odsjeka za istraživanje, Memorijalni kompleks koncentracionog logora Dachau**

Christoph Thonfeld je zamjenik direktora i šef Odsjeka za istraživanje pri Memorijalnom kompleksu koncentracionog logora Dachau. On je historičar, a svoje istraživanje i nastavu obavljao je na Univerzitetu u Bremenu, Univerzitetu u Hagenu i Univerzitetu u Trieru (Njemačka), na Univerzitetu Cheng Chi i Nacionalnom pedagoškom univerzitetu u Tajvanu (oba u Tajvanu/ROC) te na Sveučilišnom koledžu London u Ujedinjenom Kraljevstvu (engl. University College London, UK). Njegova glavna područja interesa su istorija Njemačke i Evrope 20. stoljeća (posebno period nacističke vladavine i njegove posljedice), dijahronska analiza svjedočanstava preživjelih žrtava i istraživanje počinitelja. Njegova najnovija knjiga (u koautorstvu s Peterom Daviesom, Hannah Holtschneider i Sheilom Jelen) nosi naslov *Olga Lengyel, preživjela žrtva iz Auschwitz: Interdisciplinarna istraživanja* (engl. *Olga Lengyel, Auschwitz survivor. Interdisciplinary explorations*, Palgrave Macmillan 2025).

He has published numerous scientific publications (i.a. co-editor of the Handbook on Law and Economics in Eastern Europe) as well as written various fiction and journalistic publication, the latter also relating to Bosnia and Herzegovina and other successor states of the former Yugoslavia. Dr. Pürner knows Bosnia and Herzegovina since the early 1980s and is fluent in the local language.
